Mayor's Message Utah League of Cities and Towns



This year I am serving as the 1st Vice President of the Executive Board of the Utah League of Cities and Towns (ULCT). ULCT's primary focus is representing municipal government interests at the state and federal levels. ULCT currently serves 248 cities and towns in the Utah. Other functions include providing information, training, and technical assistance to local officials on municipal issues and helping to increase public awareness of municipal responsibilities, governance, and administration.

The start of each new year is a busy time for ULCT, preparing for and engaging with the Utah State Legislature's legislative session that runs from mid-January to the beginning of March. As a board member, I serve on the Legislative Policy Committee. Bills that may have an impact on municipalities related to matters such as land use, revenues, housing, zoning, water supply, infrastructure, law enforcement, transportation, and other government roles are studied and tracked, with opposition being voiced to any that may negatively

affect our communities. Conversely, support is given to those deemed as beneficial.

An example of negative impact specific to Draper this year is proposed legislation that would allow gravel extraction operations to expand onto adjacent properties, regardless of zoning, and would exempt gravel/mining operations from local land use authority. This type of legislation affects many cities in Utah and was strongly opposed by ULCT. We worked extremely hard to prevent this bill from being adopted. Due to our efforts, it has been postponed until the interim session later this year. We will continue to fight it.

ULCT also provides the ability for officials and staff of cities and towns statewide to network and exchange ideas and experiences. ULCT holds two conferences annually that bring everyone together for training and the opportunity to talk through solutions to common issues. These

associations are valuable for neighboring communities to build and strengthen relationships as there are often situations where adjacent cities need to rely on each other in emergencies or for other types of support. ULCT gives voice to smaller communities that don't always have as much representation or resources.

The way the ULCT board is structured, board members are nominated and elected to serve a four-year commitment, starting as 2nd Vice President, then as 1st Vice President the following year, then President, and finally Immediate Past President. The Utah City Management Association also has a representative on the board. I look forward to transitioning to the role of President next year, continuing my association with ULCT members throughout the state, and looking out for local interests.

City Council Message Council Member

Each year city council members are given assignments by the mayor to serve as liaisons to City and external committees, boards, and other groups. In 2024 I will be serving as Mayor Pro Tempore, Community Reinvestment Agency Vice-Chair, Municipal Building Authority Vice-President, member of the Legislative Policy Committee for the Utah League of Cities and Towns (ULCT), member of the Audit Committee, and advisor for Draper Days.

Following are some details about these assignments:

Mayor Pro Tempore

This position steps in to perform the duties of the mayor in the event they are absent or otherwise unable to serve. This designation is for one calendar year.

Community Reinvestment Agency Vice-Chair

The city council is the governing body of the Community Reinvestment Agency (CRA), whose purpose is to assist the City in taking actions to reinvest, renew, and provide economic

development and community development for specified areas of the city. The CRA is authorized to enter into agreements in connection with community reinvestment matters. The mayor serves as CRA chair, and the vice-chair conducts the meeting in the chair's absence.

Municipal Building Authority Vice- President

The Municipal Building Authority is comprised of city council members and meets on an as-needed basis related to the acquisition, disposal, or financing of City property and assets. The mayor serves as president and the vice-president conducts the meeting if the president is absent.

Legislative Policy Committee

The LPC meets weekly during the legislative session on Capitol Hill to evaluate bills and work with the Utah League of Cities and Towns (ULCT) Board of Directors and staff to determine official ULCT positions on legislation. The LPC takes positions on legislation by a 60% consensus vote. Every city and town

can elect voting members from their mayor, council members, or senior staff.

Audit Committee

The purpose of the Audit Committee is to advise the city council on the annual audit of the City's financial statements and to recommend and monitor the annual auditing functions.

Draper Days

Members of the city council are selected to participate in planning meetings for Draper Days, the City's annual summer festival, and provide input.

SUBDIVISION ORDINANCE UPDATE

CHANGES TO THE NOTICE AND APPROVAL FOR SUBDIVISIONS

In 2023 the State Legislature changed the regulations for how jurisdictions can process and approve subdivision applications. Cities like Draper were given until February 1, 2024 to comply with these new State requirements. As part of making these changes, the City Council adopted changes to our subdivision ordinances on January 16, 2024. Residents should be aware that the new changes will affect how and when they receive notification for Public Meetings or Public Hearings regarding subdivision applications and the approval process for subdivisions.

Preliminary Plat applications will now be presented to the Planning Commission for approval at a Public Meeting, which does not allow for public comment. Notice of the Public Meeting will be provided on the City's Agenda webpage and on the Utah Public Notice Website.

Final Plats and applications for **Minor Subdivisions** (10 lots or less) without deviation requests will be approved by the Zoning Administrator. A Public Meeting or Hearing will not be held. Notice of the approval will be posted on the Community Development

Department's webpage for Administrative Decisions.

Minor Subdivision applications that include Deviation requests will be presented to the Planning Commission for approval at a Public Hearing, which allows for public comment to be taken at the hearing. Notice of the Public Hearing will be provided on the City's Agenda webpage and on the Utah Public Notice Website, and will be mailed to property owners within 300 feet

Subdivision Plat Amendment applications will be presented to the Planning Commission for approval. This could be at a Public Meeting or a Public Hearing depending upon the specific circumstances of the application. Notice will be provided in the same manner as for Minor Subdivision applications with deviations. The notice will specify whether it will be a Public Hearing or a Public Meeting.

SPRING STORM WATER ANNOUNCEMENT

As spring approaches we would like to provide easy to implement, useful and effective tips to improve our Storm Water quality:

- 1) Close dumpster and trash can lids to prevent trash from coming into contact with rain or snow and to prevent wind from blowing trash/debris onto landscaped areas and streets.
- 2) Follow manufacturer recommendations when applying fertilizers, pesticides, and herbicides.
- 3) Remove leaves and grass clippings from streets. These eventually end up in creeks, rivers, and storm drain infrastructure, causing unpleasant odors, clogged pipes, and flooding.
- 4) Avoid using water whenever possible to clean paved areas. Use brooms, leaf blowers, or pressurized air to blow dirt, debris, grass, or leaves onto lawns or gardens.
- 5) Before starting home/property improvements, coordinate with contractors to keep materials, tools, or machinery off streets and away

from storm drain inlets.

- 6) Park vehicles indoors or under cover if possible to avoid rain/snow contact. Use materials like cat litter to absorb oil/chemical spills and clean with a broom and dust pan.
- 7) Refrain from feeding waterfowl, the leading cause of watershed ecoli. When waterfowl congregate in large numbers, the watershed struggles to filter out harmful bacteria.

DRAPER CITY RECYCLED MATERIALS REPORT JULY 1 - DECEMBER 31, 2023

Curbside Recycling

From July 1 - December 31, 2023 our recycling trucks picked up 803.35 tons of recyclables from curbside containers. We call this mixed load collection as it contains plastic bottles, metal cans, corrugated cardboard, and paper. Mixed loads are delivered to Rocky Mountain Recycling Services, a material recovery facility (MRF) in Salt Lake City that uses a state-of-the-art sort line and trained staff to ensure as much recyclable material as possible is reclaimed, baled and sent to production mills across the country to be made into new products.

Mixed Load Contamination

Rocky Mountain Recycling runs a test sort each month where a driver empties the load in an open area for a staff member to sort the load and determine how much is recyclable and how much is contamination (material that cannot be recycled). Our average during this period is 16.31% contamination. This is where we need your help.


What can I put in my recycle can?

Cardboard (please flatten boxes), paper, newspaper, cereal boxes, toilet rolls and paper towel tubes, aluminum cans, steel cans, and plastic containers with necks/lids. The bin is for loose materials only—don't put recyclable items in bags.

Items to Keep Out of Recycle Bins

Plastic bags, fast food containers, greasy or soiled wrappers/packaging, wax coated cardboard, Styrofoam, packing peanuts, bubble wrap, yard waste, and

glass.

Corrugated Cardboard

We have two single stream drop off containers: one for corrugated cardboard at Public Works (72 E Sivogah Ct), and one for glass at City Hall (1020 E Pioneer Rd). During this period, residents recycled 16.4 tons of corrugated cardboard delivered and processed at Rocky Mountain Recycling. A 30-yard dumpster with corrugated cardboard weighs an average of 1.97 tons.

Glass

The City Hall dumpster recycled 55.47 tons of glass that is cleaned, dried and crushed, then sorted into various sizes ranging from pebbles to sand and even powder depending on its end market, at Momentum Recycling. ROCKY PEAK VIRTUAL ELEMENTARY

Rocky Peak Virtual Elementary (RPV) is a tuition-free online/ virtual elementary school in Jordan School District, serving students throughout Utah. RPV provides a virtual curriculum in Reading, Writing, Math, Science, and Social Studies. They also have in-person and virtual activities with their Peak Time program.

Many families find RPV a good fit for children on the autism spectrum, or who need more personalized support or different



learning paths and choices. RPV offers a blend of school and classroom culture by being a public school, but with the benefits of privatized learning through three different learning options, which all take place virtually.

The South Valley Sewer District plans rehabilitation, and to repair segments of the aging sower to ensure sension.

The South Valley Sewer District plans to repair segments of the aging sewer infrastructure in the district. Affected areas in Draper include 1000 E between Sunburn Lane and 11780 S, and 700 E between Sunburn Lane and Pioneer Rd.

Proactive measures are being taken to prevent additional deterioration and operational impacts. This project is able to use trenchless technology to install a liner inside existing pipe, and impacts will be much less than with a traditional open-trench project. Installation will take place while the old line is in service, minimizing public impact. Liner installation and reestablishing customer service connections may require minimal excavation work.

The project includes cleaning the sewer to remove sediment and debris before

rehabilitation, and bypass installation to ensure service is maintained during construction. Impacts may include increased noise and odors, and could affect roadway access and traffic. The project team will work closely with the rehabilitation contractor to minimize public inconvenience.

Notification will be delivered to each property in the area adjacent to the work before construction begins, and will include construction timing, anticipated traffic impacts, and other project impacts.

The Point of the Mountain State Land Authority (Land Authority) seeks to be part of the solution to Utah's most pressing challenges by providing a balanced mix of housing and developing sustainably. They have planned for approximately 3,300 housing units in the first development phase alone, including more than 400 affordable units. Since

January 2023, the Land Authority has temporarily dedicated some of The Point's water rights to increase flows to the Great Salt Lake (GSL). Their actions have added approximately 4114.5 acrefeet of water to the GSL, or nearly 3.7 million gallons — enough to fill six Olympic-sized swimming pools — each day! While the amount of water alone will not save the GSL, it represents the Land Authority's commitment to sustainability and regional partnership.

By creating a family-oriented

community where Utahns from various backgrounds and stages of life can live, The Point will be part of the solution to addressing Utah's housing crisis. The first phase of development alone will provide a balanced mix of 3,300 housing units, with 12.5% of those units priced as affordable.
