
# How It Works

#### What's Happening Now?





There are dozens, if not hundreds, of neighbors walking their dogs throughout a community at all times of day, all days of the week, in all weather conditions, who are often preoccupied with texting, chatting, emailing, or listening to music.

Let those who break the law know that there are more of us than them and that we do report suspicious activity.





#### Suspicious, Part 1



A PERSON IS NOT SUSPICIOUS Remember that people are not suspicious, behavior is.



THE BEHAVIOR OF AN INDIVIDUAL Displays a sense of urgency or has no apparent destination.



EXAMPLES OF SUSPICIOUS BEHAVIOR Walking among parked cars, approaching the rear of a property, trespassing, or canvassing.



ONE MORE EXAMPLE

An individual knocks at your door and claims to be at the wrong location.





### Suspicious, Part 2



WHAT YOU SEE IS SUSPICIOUS That gut feeling that something may be wrong.




A SUSPICIOUS PARKED VEHICLE Parked in an unusual location or unoccupied and idling.



EXAMPLES OF A SUSPICIOUS VEHICLE Traveling at a high speed or a low speed, or without lights when lights would be appropriate



INSIDE THE VEHICLE Apparent business transactions from a vehicle; suspicious items or property inside.







## Calling 9-1-1

#### WHEN TO CALL

Call any time a police response may be needed. Please remember, you are not bothering us.





#### What You Need to Know



Clarify exactly what is occurring. Be sure to provide all the necessary details, including a description of the subject.



Know where you are and be as specific as possible. Mention the county, address, and nearby landmarks.




Remain calm, speak clearly, let the operator ask questions. You do not need to speak to the officer.
