

CANDIDATE REQUEST TO USE A NICKNAME ON THE BALLOT AND SUPPORTING AFFIDAVITS

Except as otherwise provided in Utah Code § 20A-6-109, pursuant to Utah Code § 20A-6-109(1), a candidate's name on the ballot shall be the candidate's legal first name followed by the candidate's legal surname. An election offer shall place a candidate's nickname on the ballot if the candidate submits a request, an affidavit, and supporting affidavits as specified in Utah Code § 20A-6-109(3). However, a nickname may only be used on a ballot if the election officer determines the following: 1) the nickname does not imply that the candidate is an individual other than the candidate, 2) the nickname does not constitute a slogan, 3) the nickname does not associate the candidate with an economic, religious, political, or other group, issue or opinion, 4) the nickname is not offensive, profane, or spurious, and 5) the nickname is not a title, rank, degree, certification, job description, or similar designation. The nickname may only be placed as follows: 1) before or after the candidate's legal first name, before or after the candidate's legal middle name, if the candidate's legal middle name appears on the ballot, or 3) in place of the candidate's legal first name.
